8. UNFINISHED BUSINESS

1. Infiltration study

Update

Chris Gallant mentioned that the general manager had requested that flow meters be placed on Ohio Road and at Parlee Beach. Chris presented charts illustrating the flows for both meters. As for Parlee Beach, some concerns have been brought forward regarding water drains and the on-site showers. Chris has made recommendations to address these issues including redoing the showers to include roofs and a curb to prevent run off water from entering the showers. Harry McInroy also expressed his concern regarding sand entering into the system from the showers. Chris is recommending bigger basins to capture the sand as well as regular maintenance. The flow meter will remain on Ohio Road to continue monitoring the flows in this area as it showed a spike during the August 10th major rain event.

2. Funds / Subsidies

a) Building Canada Fund

Update

 - a) Contract 2 (St-John Street piping)

Update

Chris Gallant mentioned that this project is complete. However, the hydro seeding was of poor quality and he has asked the contractor for it to be redone.

5. Parlee Beach Sanitary Sewer System Improvements and lift station No. 10.

Update

Chris Gallant mentioned that this project is complete. A final walk through was completed and all involved parties are satisfied with the work.

6. Town of Shediac – Gallagher Street refurbishment

Chris Gallant mentioned that the refurbishment is moving along well. However, it is behind schedule. The timetable was tight is the first place nevertheless the contractor was aware when bidding on the contract. Laura Gallant wondered if the rain event of August 10th affected the project. Chris mentioned that there were issues with sump pumps, but the street held up well. Harry McInroy questioned if these sump pumps would be an issue once the project is completed. Chris confirmed that they will be connected to the Town of Shediac's storm sewer system, therefore would no longer be infiltrating into the sanitary sewer system.
