 - a) Contract 2 (St-John Street piping)

Update

Chris Gallant mentioned that this project is complete. There remain a few issues to complete the EIA requirements, such as the monitoring of potable wells in the area. The post construction potable wells testing has revealed the presence of bacteria in a couple of wells. He will notify the property owners and take steps to address the situation. He will provide us with an update at the next meeting.

5. Parlee Beach Sanitary Sewer System Improvements and lift station No. 10.

Update

Chris Gallant mentioned that this project is complete. Additional road surface repairs are being conducted on Church Street and he will survey the work to ensure it is acceptable.

6. Town of Shediac - Gallagher Street refurbishment

Chris Gallant mentioned that the construction is moving along well. However, it is approximately a month behind schedule. Chris also mentioned that sewer main video shows that the new sanitary sewer main is looking very good. However, the existing sewer main on Centennial Street is showing more infiltration than the initial video. This is possibly due to the higher water table since the storm.
