2. 2023 Shediac and Scoudouc Sewer Rate

- 1. Infiltration and capacity study
 - a) Infiltration

Update

Chris Gallant, Englobe Corp., mentioned that we are receiving good data from the recent weather events. He added that they also like to monitor a period of dry weather, then the flow meters could be relocated.

b) Capacity

Chris Gallant, Englobe Corp., mentioned that due to sickness amongst employees, they could only finalize the report at the last minute. He proposed that they wait to present it at the next monthly meeting so that the director, operations, has time to review it.
