Update

The director, operations, mentioned that a letter from the province dated June 19, 2023, confirms that the funding for phase 2 of the project has been approved. Chris Gallant, Englobe Corp., mentioned that his team at Englobe will discuss the best options to proceed and will submit to the GSSC their recommendations in writing. He expects that tendering could take place in the fall, with construction starting late this year or early next year.

Update

- 5. Town of Shediac and GSSC West Shediac refurbishment
 - a) Inglis Street

Update

Chris Gallant. Englobe Corp., mentioned that construction is at a standstill for a couple of days as the wrong manholes were ordered. The work is still expected to be completed on schedule.

6. Town of Shediac and GSSC - Pleasant Street refurbishment

Update

Chris Gallant, Englobe Corp., mentioned that pipe work on the bottom of Pleasant Street, on a section of Centennial Drive, and on Seaman Street is near completion. The contractor will start pipe work on Elizabeth Street next week. There is a delay with the utility pole relocation. However, the contractor is working around it. The contractor mentioned on-site that the 2nd half of Pleasant Street may have to wait until next year. The director, operations, mentioned that he is concerned that the refurbished lift station No. 5 will have increased pump flow and will continue to flow across to Shore Drive if Pleasant Street isn't completed (new force main part of the top section of Pleasant Street). Chris Gallant noted the concern, and it will be discussed with the contractor.

8. Lift Station No. 5 refurbishment

Update
