- 1. Infiltration and capacity study
 - a) Infiltration

Update

Chris Gallant, Englobe Corp., mentioned that the flow meters are installed, and he showed some data that was recently collected. He also mentioned that one of the flow meters seems to have been mistakenly installed in a storm manhole. It will be reinstalled properly.

b) Capacity

Update

The Town will prepare a funding application to assist with the cost of phase 1a) of the new trunk sewer project. The board members will be kept up to date on the subject.

a) Phase 1 - Headworks Building

Update
