They are waiting for new I&I guidelines to come out before presenting the report. There's a possibility that funding could be available to municipalities impacted by infiltration and inflow issues.

2. Cap-Brulé WWTP upgrades.

a) Phase 1 - Headworks Building

Update

Chris Gallant, Englobe Corp., mentioned that work is progressing well and is on schedule. They have completed a few concrete pours and are preparing forms for additional pours. They expect to be out of the ground by winter so the building can start going up early in the Spring.

b) Phase 2a) - Major Equipment

Update

Chris Gallant, Englobe Corp., mentioned that the installation of the bored forcemain will likely be more expensive than anticipated. They are preparing a report to present in Fredericton to request more funding, or the permission to install a major part of the forcemain by excavation through the marsh during winter months.
