7. NEW BUSINESS

1. Town of Shediac and GSSC – Main Street refurbishment (King Street to South Cove Road)

The general manager mentioned that the Town of Shediac will conduct a refurbishment of a section of Main Street, from King Street to South Cove Road, and a section of South Cove Road next year. He added that this could allow us to redirect some sanitary flows away from the sanitary main (Main Street to Greenwood) down the refurbished section of South Cove Road instead.

2. Lift stations No. 1 and No. 8 evaluation (refurbishment)

The general manager mentioned that, according to our 5-year plan, we should refurbish lift station No. 1 and No. 8 next year (like the 4 lift stations we refurbished the past few years). He suggests that we ask Englobe Corp. to submit a proposal to this effect. The members agreed.

Janice Cormier requested that the address of the lift station appears with the lift station No. to better understand the location of the affected lift station. The general manager agreed.

8. UNFINISHED BUSINESS

1. Infiltration and capacity study

a) Infiltration

Update

2. Cap-Brulé WWTP upgrades.

a) Phase 1 - Headworks Building

Update

Chris Gallant, Englobe Corp., mentioned that work is progressing well and the underground work is essentially completed. The next step will be the erection of the building structure. A weekly update from the engineers is forwarded to the board members.

b) Phase 2a) - Major Equipment

Update

Chris Gallant, Englobe Corp., mentioned that the generators are now expected by the end of October.

c) Phase 2b) - Lagoons, Outfall

Update

Chris Gallant, Englobe Corp., mentioned that a draft letter for the RDC has been completed and being reviewed internally. The intent is to meet with government representatives in Fredericton and discuss the possibility of changing the method of the installation of the effluent forcemain, or the possibility of additional funding. The letter will be sent to the general manager for review once ready.

Chris Gallant, Englobe Corp., mentioned that the relining of the forcemain has concluded. He also mentioned that the general contractor for the refurbishment portion expects the equipment to arrive late December. The work will take place in January 2026.

The general manager mentioned that he forwarded the weekly updates from the consulting firm EXP to the board members.
